## Business Update – Q4 & FY25

**Kolkata, April 02, 2025:** Bazaar Style Retail Limited (BSRL) reports its Business Update for the Quarter and Full Year that ended March 31, 2025.

### Key Highlights:

- Revenue growth of **55% YoY to Rs 3,456 Mn** in Q4FY25 and **38% YoY to Rs 13,438 Mn** in FY25.
- Sales Per Square Feet (PSF) stood at **Rs 679 per month** in Q4FY25 and **Rs 721** in FY25.
- Same Store Sales Growth (SSSG) stood at **20%** in Q4FY25 and **13%** in FY25.
- Total No. of Stores stood at **214 stores** and the Total Rental area stood at **19.21 Lakh Sq Ft**, as of March 31, 2025. The Company opened a total of **15** new stores and closed **Nil** stores during Q4FY25.
